# "Survivor"





If your chapter is looking for ideas to give back to our communities by supporting our students without housing, students in foster care, and students who qualify for McKinny-Vento funds, here are some resources for identifying organizations in your area:

Washington State Department of Commerce, Office of

Homeless Youth (OHY) works with partners and communities to establish ongoing and future funding, policy, and best practices to improve the lives of homeless youth and young adults in Washington. Funding for the Office of Homeless Youth is specifically allocated to several programs, each with a targeted mission, working together to increase youth and young adults' stability and well-being. The site has a <u>Provider List</u> available detailing partners by county. <u>Westside Baby</u> – The Giving Circle meets the basic needs of children to promote safety, security and healthy development. They collect and distribute diapers, clothing, and equipment throughout Western King County. WestSide Baby's model is unique. They receive donations from the community, check and sort those donations, and distribute them directly to 100+ partner agencies.

**Youthcare** in Seattle works to end youth homelessness and to ensure that young people are valued for who they are and empowered to achieve their potential. YouthCare envisions a community where no young person experiences homelessness, all young people have the opportunity to thrive, and the systems that oppress them are dismantled. WSO chapters have a long history of sharing great Educational Excellence workshops and events. Have you shared your best or most impactful program over

the last few years with other chapters? Would you like to? We are collecting information about what programs you have pulled together that have made a lasting impression. We are trying to update our state website with information to inspire other chapters.

I was recently on a call with EEC chairs from all over the Western Hemisphere where we shared the great things our state and chapters have been doing. I was able to inspire and share information about our past statewide literacy program conducted under past President Susan Fritts, our purposeful purse project under past President Sherri Wagemann and our mental health emphasis under past President Pat Bennett-Forman. The efforts that chapters have gone through to participate in these statewide efforts and the documentation of them through slideshows and newsletter articles helped me to share some things that others in the DKG family had not considered. had offered clock hours in the past and discontinued, others were keen to learn more about the process and how they might apply as they thought it would be an incentive for members and also an opportunity to recruit members. And, in the recruiting members vein, Second Vice President Jessica Tufts and her team are doing a great job in providing membership recruitment and retention strategies, and we at the EEC are here to help in this effort as well by supporting chapters with excellent programing and the ability to offer clock hours.

Did you know that WSO DKG can offer clock hours for educators for eligible programming? A great program is a wonderful way to introduce eligible educators to the world of DKG. The application forms and additional information are available at www.dkgwa.org/forms or via email from teridkg@gmail.com. Program proposals must have the Professional Qualifications block completed with enough information to show the capability to present for each presenter or have a completed resume/ vitae attached for each presenter. Clock hour proposals must be received by DKG WSO at least ten calendar days prior to the beginning of the proposed event. Upon approval, a Clock Hour Registration Packet will be sent to the contact person/facilitator for duplication and distribution. The packet will include a cover/instruction letter, in-service sign-in sheet, Request for Clock Hours form, and program evaluation form. All clock hours must be approved by DKG WSO prior to the commencement of training.

I am looking forward to an inbox of emails with excellent EE programs from your chapter to share state and worldwide, and for your clock hour application form.

### **Addressing our membership challenges**

Think of a place that you frequent often and enjoy being at. Then reflect on how you feel when you walk into

that location. For me, I feel loved, wanted, and welcome. I am guessing that the location you were picturing gave you similar feelings of warmth. If you were to think of a place you go that you dread, your feelings when you enter there are probably not as warm and fuzzy. As humans, we naturally seek out these places that make us feel wanted. Does DKG give these feelings to its members and prospective members? This applies to all levels of the organization including the chapter level. What are you doing in your chapter to build relationships with members?

### WSO Board explores Quadrant/Area reconfiguration.

The WSO Executive Board will vote on a proposed reconfiguration of the current quadrant and area map at the 2024 Spring Convention. Prior to that time, three virtual Q&A sessions will be held so that all state members can learn about the proposals, ask questions, and raise concerns to be addressed prior to the vote. Information on these virtual sessions is found in the box inset in this article.

The proposals to reconfigure are a result of discussions by area liaisons, the Executive Committee and two surveys sent to chapter presidents in February and April 2023 by an appointed ad hoc committee. Six of ten areas have only 1 or 2 chapters. Several areas have only 15-20 members. The workload and expense for area workshops and state meetings is burdensome for smaller chapters and areas.

Survey results indicated 90% of respondents wanted quadrants rather than areas to be hosts for state conventions and 86% wanted quadrant workshops in place of or in addition to area workshops. Respondents indicated a need for flexibility in defining areas and area activities.

Quadrant boundaries were drawn in 2010 to reflect a similar number of members and chapters in each geographic section, keeping the areas intact. Current membership now shows an imbalance in areas and quadrants; realignment is necessary.

Based on survey results and the current number of chapters and members, the ad hoc committee proposes:

**Proposal 1:** Move from Quadrants to three regions: Northwest (Areas 6, 7, 10), East (Areas 1, 2, 3, 8), and Southwest (Areas 4, 5, 9), and the format and monies marked for quadrant workshops be transferred to the region workshops.

Rationale: To maintain balance in each region regarding number of chapters and number of members; if changes are needed in the future, the word regions is less restrictive than quadrants. **Proposal 2:** The rotation of state event hosting duties be assigned to regions, rather than to an area. Further, the hosting region for the state convention will be on the same side of the state as the convention.

Rationale: Spreads the workload for volunteers and expenses to more chapters and equalizes the financial and time burdens associated with hosting. Further, enables a region to recruit more volunteers for on-site duties as the travel burden is reduced by having the convention hosts located on the same side as the convention.

**Proposal 3**: Every 5 years, the state president appoint a committee to study the demographics of the regions to determine if realignment is appropriate and take such action as is needed to reflect similar number of members and chapters in each Region.

Rationale: Keeps WSO more responsive to demographics and member/chapter needs.

Additional proposals may be made concerning area boundaries or allowing for greater flexibility in terms of where a chapter chooses to attend an area workshop. More details on the above-stated proposals and other ideas will be shared on the state web site and at the Q&A sessions.

### Update on HR 744: "Supporting the Mental Health of Educators and Staff Act of 2023"

**Education Policy/Education Committee** 

WSO DKG passed a resolution in 2022 to advocate for legislation to improve mental health services for educators and other school staff. At the same time, the DKG U.S. Forum passed a similar resolution. Work by Oregon and Washington members resulted in a bill (H.R. 744) being introduced to Congress in February 2023 by Oregon Representative Suzanne Bonamici. The bill was referred to the House Subcommittee on Health. Since then, Representative Bonamici has been successfully working on obtaining bi-partisan support for the bill known as "Supporting the Mental Health of Educators and Staff Act of 2023."

In July 2023, a companion bill (S. 2530) was introduced to the Senate by Senator Robert Casey of Pennsylvania. It has been referred to the Senate Health, Education, Labor, and Pensions Committee. In early October, we were informed that Representative Derek Kilmer of the Washington 6<sup>th</sup> Congressional District has become a co-sponsor of H.R. 744. Progress is being made, albeit slowly.

H.R. 744 established grants and requires other activities to improve the mental health of education professionals and other school staff. It calls for a campaign to encourage staff to seek support and treatment and will help reduce the stigma associated with getting help. It also calls for the dissemination of best practices to prevent suicide and improve mental health resiliency for educators and other school staff.

"While this bill is not generously funded (\$10M), it is a step in the right direction in that it recognizes the need to provide mental health support to educators and it promotes the dissemination of best practices for building resiliency," according to Pat Bennett-Forman, WSO representative to the U.S. Forum and a member of the Forum task force on mental health. "These bills are an important first step," she added, "but in order to get them passed into legislation, our members will need to step up in terms of contacting their Congressional representatives."

Bennett-Forman outlined several opportunities that interested members could take to promote the legislation, including: (1) contacting Congressional Representatives to have them become co-sponsors and to encourage them to help move this bill to the vote; (2) writing our senators in favor of S. 2530, urging its passage; (3) writing our elected officials who have signed on to thank them for their support.

A complete list of co-sponsors and information about the bill may be found at the Congress web site: <u>www.congress.gov</u>. This web site allows members to identify her Congressional district and representative in order to send an email. All that is needed is to enter one's home address, click on the name of the representative and then click on "contact me." Finally, a click on "send an email" will bring up a box in which the member can type her message to her representative.

The internships require a total of 600 hours (direct and indirect with students). I live in Colville and work in Republic, WA. I am working half-time while I complete my field experience hours (700 hours total). I have applied for both Internships and feel confident that I will be successful. My practicum cohort meets weekly on Friday mornings to share experiences, gain insight and learn from our assigned faculty. It has been a wonderful experience so far. I changed my program emphasis from the General Program to a specialization in Crisis and Trauma.

I took three classes over the summer and began Chapter 4 of my dissertation. Unfortunately, I was unable to complete chapter four and I am taking it again along with another course. 
### From Alia, who is working on Administrative credentials:
